The draft Plan is being amended in response. The next stage being Section 14 Public Consultation. Possible Future Projects: include a) public awareness campaign regarding ‘dark skies’; exploring potential for traffic calming through village; exploring damage caused by driving over verges on Middle, Back and Front Streets which could include consultation on widening roads. Footpath to Berryfields: Agreement has been reached between Warwickshire County Council and Cotswold Voluntary Wardens regarding completing the works recommended in his 2017 report. It was resolved that a letter of thanks be sent to Alan Hesse in respect of work done opposite Featherbed Lane. Action JS Middle Street Bollards – It was resolved that Cllr Hawkins will thank the householder for his cooperation and ask for his continued support. The matter will be reviewed again in July 2018.
